WHEREAS, Farmlake Developers, Inc. (the "Developers") developed a certain tract of land known as Farm Lake, Phase IV, as shown on a plat recorded in Plat Book 124 at page 879 in the Register of Deeds for Spartanburg County (hereinafter sometimes referred to as the "subdivision"), and,

WHEREAS, the Developers previously established Land Use Restrictions, Protective Covenants and Building Standards for the lots shown on the aforesaid plat, which were duly recorded in Deed Book 61F at page 444 in the Register of Deeds for Spartanburg County (hereinafter referred to as the "Restrictive Covenants"), and,

WHEREAS, pursuant to the Restrictive Covenants, the undersigned owners of a majority of the lots in the foregoing subdivision desire to modify and amend certain provisions of the Restrictive Covenants so as to extend the term of their effectiveness,

NOW, THEREFORE, in consideration of the premises and the mutual benefit derived by the property owners from the Restrictive Covenants, the receipt and sufficiency of which is hereby acknowledged, the Restrictive Covenants are modified and amended as follows:

- Paragraph 41 of the Restrictive Covenants is hereby modified and amended to read as follows: "The restrictions, covenants and standards contained herein are to run with the land and shall be binding on all parties and all persons owning a lot or an interest in a lot in the Farm Lake, Phase IV, subdivision until January 1, 2029, at which time said restrictions, covenants and standards shall be automatically renewed for successive terms of ten (10) years each, unless and until the owners of a majority of the lots in the subdivision shall agree in writing at least thirty (30) days before January 1, 2029 or the end of any later renewal term, to terminate or otherwise modify or amend said restrictions, covenants and standards. Nothing contained herein shall limit in any manner the property owners' right by consent of the owners of a majority of the lots in the subdivision to further modify or amend the restrictions, covenants and standards at any time during the initial term or any renewal term hereof."
- 2) The Restrictive Covenants shall in all other respects remain in full force and effect and are hereby incorporated by this reference, except as modified hereinabove.
